- Financial institutions and mining businesses are taxed at a rate of 2% of the total wages paid by the entity each calendar quarter.

- Each business entity engaged in business in Nevada whose Nevada gross revenue in a fiscal year exceeds \$4,000,000 is required to pay a tax on such excess gross revenue at a specified rate for the industry such entity is primarily engaged.
- O Some examples of the applicable tax rates include:

Construction .083%

Manufacturing .091%

Real Estate .25%

Health Care and/or Social Services .19%

Retail .111%

Finance and Insurance .111%

- NOTE: All "Retailers" are subject to the Local School Support Tax
- If your business sells tangible personal property at retail, then the business is subject to a tax at 2.6% of the gross receipts from any sale of all tangible personal property sold.

SOLE PROPRIETORSHIP (NOT GOVERNED BY ANY PARTICULAR NRS CHAPTER)

- 1. Filing formation documents with Secretary of State's Office is not required. Obtain a Federal Employer Identification Number (EIN) if the Sole Proprietorship has any Employees and/or files any excise or pension plan tax returns.

- Comply with all applicable state and local business licenses and permits;
- Have stockholders' equity of at least \$1,000,000, or such greater amount if so required by the Commissioner;
- Pay the full amount of the initial stockholders' equity in cash before the Trust is authorized to commence business:
- Maintain at least 25% of its required stockholders' equity in cash and at least an additional 25% of its required stockholders' equity in case or cash equivalents (CDs, money market funds, or other insured deposits) (see NRS 669.100);
- Have the Board of Directors or Managers meet at least quarterly, if required by the Commissioner (NRS 669.115); and
- Comply with any other provisions that the Commissioner may reasonably require to protect the public interest.
- 1. Must be Organized as a Corporation or LLC in Nevada, or Authorized to do business in Nevada as a Foreign Corporation or Foreign LLC.
 - Articles of Incorporation, Articles of Organization, or Qualification to do Business must contain:
 - The name adopted by the licensed trust (unique from any other trust company in Nevada):
 - » The Trust's name may not contain the word "Trust" or any derivatives of the word "Trust," unless the name complies with specific requirements set out in NRS 669.095(2):
 - Statement that the purpose of the formation of the entity is to create a trust company:

- 11. Every Officer, Director, Person with at least 25% ownership, member of a firm or partnership, or any person authorized to initiate transactions to the trust account must complete personal information forms and complete a background investigation.

- 12. Submit to a Pre-Opening Examination by the Commissioner (see NRS 669.065 for the procedure and other requirements).
- 13. Each Director or Manager will be investigated by the Commissioner:
 - Within 90 days after the license application is filed, the Commissioner will investigate the application and the applicant to determine if the directors/managers are fit for the position, have adequate financial standing, the name complies with the requirements, and that the Trust Company meets all other statutory requirements (see NRS 669.160).
- 14. Submit Documents (Articles of Incorporation/Organization or Qualification to do Business and Initial List/Business License) proving that the Trust Company has been properly formed in, or authorized to conduct business in, Nevada.
